I, the undersigned, agree that as a condition of volunteering in the Closet Envy Consignment Event above, I represent and warrant the following to be true and correct:

_____ (initial) I have reviewed my contact information and I verify that all information is current and accurate.

_____ (initial) I take full responsibility for, release and hold harmless Closet Envy, its owners, officers, elected officials, agents, employees, contractors, other volunteers and the lessor/lessee or owner of the space where the event is held, from any and all liability, claims, demands or causes of action that I may hereafter have for injuries or damages arising out of my participation as a volunteer in the Closet Envy Consignment Event, including, but not limited to, losses caused by the negligence of the released parties or owner of the premises on which the event is held. I further agree that I will not sue or make any claim against the released parties for damages or other losses sustained as a result of any injury, or death, arising from my participation as a volunteer in the Closet Envy Consignment Event. I also agree to indemnify and hold the released parties harmless from all claims, judgments and costs including attorney's fees, incurred in connection with any action brought as a result of participation in the Closet Envy Consignment Event activities.

_____ (initial) I understand that, at times, Closet Envy takes photographs of its events to promote sales. If I do not wish my image to be used in Closet Envy's promotions, I will notify the photographer in writing at the time a picture is taken. Otherwise, I agree to allow my image to be used in Closet Envy's sale promotions.

_____ (initial) I am volunteering for the sole purpose of assisting with operations of the event in exchange for early shopping rights, and an increased consignor % for 1 or more shifts. I am volunteering in an ethical manner and agree that I am not attempting to learn the business practices of Closet Envy, operations techniques, or any other business matters that may or may not be trademarked, registered or proprietary in any way. As a result, I agree to keep strictly confidential, all knowledge and information I learn from my participation in the Closet Envy Consignment Event, about the consignment business and I further agree not to use any such knowledge or information for personal, professional or financial gain.

_____ (initial) I agree not to start, purchase, own or operate another upscale women's consignment event, in the DFW, Texas area, within two (2) years of my participation in this Closet Envy Consignment Event.

_____ (initial) I understand that if I fail to appear for my scheduled volunteer shift, without proper notice and attempts to fill my volunteer position, I will be prohibited from volunteering or consigning at a future Closet Envy Consignment Event. If I am not able to complete a work shift, I agree that I will find a comparable worker to take my place, whether it's a friend, spouse, parent, etc., or another volunteer who has agreed to switch shifts with me, and I will notify Closet Envy of such changes ASAP.

_____ (initial) I understand, if I fail to appear for my scheduled volunteer shift(s), and I am a consignor, \$25 per missed shift will be deducted from my earnings check.

_____ (initial) I agree to be ON TIME and fulfill my entire work shift in order to receive the benefits and avoid the consequences of this Volunteer Agreement.
